Unless accompanied by a 'Request for Fee Exemption' form, a deposit of \$100 is required with submission of this application. At the time of reservation only an estimate of total cost can be determined.

<sup>\*</sup>The custodial services fee is charged once per event. The fee is not a daily rate. For example, if a dance competition spans the course of three days in the FAC, the custodial services fee is \$200. The lessee is responsible for keeping the area clean during the event. Paid custodial services occur at the conclusion of the event.

All fees must be paid at least two (2) weeks prior to scheduled event. Fees are payable to the Hart County Board of Education.

The approval to use school facilities is limited to the dates, times, and areas specified in this application. The Superintendent reserves the right to cancel any permission granted. The applicant agrees to pay for the use of the school facilities and any required services according to the fee schedule set by the Hart County Board of Education. The applicant shall notify the Hart County Board of Education Office of any changes to the request to use school facilities.

The applicant shall ensure that tobacco and alcohol products are not used while on school property, inside and/or outside and that the facility is left in a clean, orderly and undamaged condition. Failure to do so will likely lead to the group/organization no longer being allowed to use any Hart County Schools facility in the future.

Lessee is responsible for any injuries or damage to property that occurs on Hart County School System property and must complete the Recreational Joint-Use Agreement prior to the date of the event. Lessee agrees to provide a current Certificate of Liability Insurance with coverage of a least one million dollars (\$1,000,000.00) to the Hart County Board of Education prior to the event. (Required by Georgia Law).
